• VP reports: CCC's VP, Michels met with CCC's new Vice-President, Tammeil Gilkerson regarding security issues. DVC's VP, Wapner reported on department transfer procedures and suggested that the UF work with the Academic Senate to come up with a protocol for departmental transfers and/or modifications. A STRS workshop will be held at DVC on Friday, Nov. 8, in the BFL conference room at 1:00 pm, and the annual UF Benefits Conference will be held at DVC on April 4 in the Trophy Room starting at 8:30 am.
