- 2. EXECUTIVE BOARD MINUTES -

Following a motion by Mayfield, seconded by Michels, MSU, to approve the minutes from the February 12, 2015 Executive Board meeting.

3. ANNOUNCEMENTS-

- Vice Presidents from each campus were confirmed by a member vote: DVC VP Marina Crouse; CCC VP Jeffrey Michels; and LMC VP Milton Clarke.
- Auditor/Accountant Bill Millias will be in the office next week to review financial statements and to conduct an internal audit for the 2013-14 fiscal year.
- An online survey regarding UF/District negotiations was sent to faculty and so far, 420 faculty have participated.
- The United Faculty reached a tentative agreement for 2014/2015. Executive Board members voted to present the agreement to UF members for ratification.

Following a motion by Dildine, seconded by Koller, MSU, to accept the UF/District Tentative Agreement and to recommend it to UF members for ratification.

• Dahl-Shanks announced that FACCC is having their spring 2015 elections and she is nominating Part-time Faculty Advocate and Executive Board member, Doug Dildine for part-time officer on the FACCC board.

4. SALARY DISCUSSION-

Executive Board members discussed faculty salaries and the salary schedule. The E-Board agreed that the UF should be seeking an ongoing raise in 2015/2016.

5. UF QUARTERLY FINANCIAL STATEMENT-

Treasurer Mayfield presented the 1st Quarter 2014-2015 to Executive Board members for their review and approval. After a lengthy discussion Executive Board members voted to approve it as follows:

Following a motion by Koller, seconded by Goehring, MSC, with one abstention (Treasurer Mayfield abstained from the vote) to approve the financial statement year to date.

6. CONTRIBUTION ADVOCACY CONFERENCE BREAKFAST-

Eight UF Executive Board members and five student interns will attend the Faculty Association of California Community College's Advocacy and Policy Conference on March 1st and 2nd. The UF will help to sponsor 2 buses to transport students to the "March in March" event to be held at the CA State Capitol on March 2, 2015

Appell stated FACCC requested a \$500.00 contribution from the UF PAC for Assembly member candidate Jose Medina. Medina is Chair of the Higher Education committee and will be an honoree at the FACCC-PAC sponsored breakfast event being held at the Holiday-Inn, Capitol Plaza in Sacramento on March 1, 2015.

Following a motion by Michels, seconded by Dahl-Shanks, with 3 abstentions, to approve a UF PAC donation of \$500.00 to Jose Medina's campaign run for CA Assembly in 2016.

7. BRIEF REPORTS-

• VP reports: VPs reported on UF activities on each campus.

CCC's Michels stated they are hiring a new President and he will serve on the hiring committee. He held a faculty evaluation training seminar and has scheduled a few more in the coming weeks. Enrollment management has been the big discussion on campus and construction is posing a problem for all. Michels went on to say that there are initial salary placement issues that need to be addressed.

LMC's Clarke stated they are putting together a campus wide 40th birthday celebration event. He went on to say there is a minor organizational shuffle going on where some departments will be merged together. There has been discussion on campus regarding compressed calendar issues.

Part-time Faculty Advocate Dildine attended the CWA/CPFA co-sponsored event. They arranged teams to go meet with legislators to lobby for part-time faculty rehire rights, parity pay, office hours and other issues facing part-time faculty.

DVC's Crouse stated she has attended many committee meetings.

UF Student Intern Coordinator Mickles introduced 2 new UF Interns, Camilia Dillard and Gerald Macadangdang. All interns gave a talk on their political activities and expressed their excitement of the upcoming March in March event in Sacramento on March 1 and 2. The United Faculty will pay for the UF Interns' expenses and transportation.

The UF Benefits conference will be at DVC on Friday March 20, 2015, from 9am-2pm in the Cafeteria. CCCI Lobbyist David Balla-Hawkins will give a talk in the morning session, and retired Congressman George Miller will be the keynote speaker for the afternoon session. Dahl-Shanks will send out a preliminary draft of the Benefits Conference Agenda and the links for registration soon.

Wapner and Michels attended the recent BFA meeting and stated most districts have finished their negotiations meetings with pretty good results. They discussed issues regarding San Francisco City College.

Appell attended Congressman Mark De Saulnier's swearing in ceremony and his presentation at DVC.
