DVC's VP, Crouse stated she attended a meeting regarding a faculty member improvement plan. She went on to say that the contract needs to be clearer about how faculty improvement plans are administered. At the Box 2A meeting they discussed the approved counseling position openings.

LMC's VP, Clarke stated he attended the Box 2A meeting and they discussed a hiring committee issue regarding an open Box 2A position and preference rights issues.

CCC's VP, Michels stated that a part-time faculty member filed a grievance, and he and the member will be meeting with the college president in an effort to find an informal resolution.

The United Faculty Internship Program is under way with new ideas. UF Vice Presidents are on board to recruit new students to work with the UF and to register students to vote, attend conferences, work in the UF office, and to prepare them for next Fall's election process and

empower them to advocate for student issues and concerns. The UF will hire 2 students from each campus in the spring.
