believe she's in her 3rd year tenure track, and we're okay with her being a non-voting member, if she can't vote.

Following a motion by Michels to approve the variance as written above, with no second. Motion did not carry and was denied for Faith Watkins to participate on the hiring committee for LMC's FT English hire.

5. VARIANCE GUIDELINES REVIEW-

Executive Board members reviewed the UF Variance Guidelines and approved all revisions.

Following a motion by Mayfield, seconded by Wapner, MSU, to approve the changes to the UF Variance Guidelines.

6. STATEWIDE REPORTS-

Michels announced AB 897 (Medina) would raise the cap for part-time faculty from 67% to 85%. CCCI is co-sponsoring this bill with FACCC and CFT. SB 777 (Rubio) would require Community College Districts to reach 75% fulltime faculty within 10 years.

Michels motioned to give Connie Leyva for Senate 2022 a campaign contribution connected to the FACCC PAC breakfast event of \$1,000 from the United Faculty's Political Action Fund.

Following a motion by Michels seconded by Dildine, MSU, to give Connie Leyva for Senate 2022 a campaign contribution for speaking of \$1,000 from the United Faculty's Political Action Fund.

7. EXECUTIVE SESSION –

Leadership Reports-

LMC's VP, Clarke, reported he held an evaluation training workshop on February 12, 2019 at LMC.

Elections for UF VP confirmation votes nearly ready to begin.

DVC's VP, Mayfield, stated he has been fielding paycheck code questions from Faculty members. There is a meeting scheduled to review the coding with District management. He went on to say the Equity Hour Program at DVC is limiting Faculty participation due to funding problems.

Executive Board members discussed 2019 negotiations preparations, faculty survey and forums, work groups, and CRC updates.
