CCC Nursing Department Chair, Cheri Etheredge wrote:

The nursing department has been given two full time positions for Fall, 2019. The positions are posted and we will begin to set up the hiring committees very soon. Currently we have two non-tenured faculty in our department who have been in the department for a while as part time faculty and then full time tenure track. They will be working directly with the new hires-team teaching a big course. I would like to ask that they be given special permission to serve on interview committees for the new hires.

## 5. LEGISLATIVE REPORTS–Hearing on Bill

State Senator Susan Rubio introduced SB-777 and it passed the Senate Higher Education Committee. This bill would require a district that has less than 75% of its hours of credit instruction taught by full-time instructors to make, at a minimum, an annual 10% reduction in the district's deficit, defined as the gap between 75% of the total district credit hours taught and the total of those taught by full-time faculty.
